



# Distributor's Limited Warranty

## HONDA MOTOR SCOOTER

This warranty is limited to Honda motor scooters distributed by American Honda Motor Co., Inc., 100 West Alondra Boulevard, Gardena, California 90247 and sold by American Honda or dealers within the United States, Puerto Rico, and the U.S. Virgin Islands authorized by American Honda to sell motor scooters. *This warranty is given by American Honda to the first retail purchaser only and is not transferable to subsequent owners.*

### TO QUALIFY FOR THIS WARRANTY:

1. The Honda motor scooter must be purchased from a dealer within the United States, Puerto Rico, or the U.S. Virgin Islands who is authorized by American Honda to sell motor scooters; and
2. The Honda motor scooter must be registered at the time of purchase on a form provided by American Honda Motor Co., Inc.; and
3. Prior to delivery to the purchaser, set-up and pre-delivery service must be performed by a dealer who is authorized by American Honda to sell Honda motor scooters.

**THE OBLIGATION OF AMERICAN HONDA MOTOR CO., INC.:** The obligation of American Honda under this warranty, is limited to repairing or replacing, at its option, any part which is *proven to be defective in material or factory workmanship under normal use for the applicable period stated below. Parts repaired or replaced under this warranty are warranted only during the balance of the Honda motor scooter's warranty period.*

*Warranty repairs will be made without charge for parts or labor. All defective parts replaced under this warranty become the property of American Honda Motor Co., Inc.*

**WARRANTY TIME PERIOD:** Honda motor scooters are covered by this warranty for a period of 1 year from the date of purchase, regardless of mileage.

A Honda motor scooter that has been used by the dealer as a demonstrator shall have warranty time computed from the date the motor scooter was first placed in service as a demonstrator.

**TO OBTAIN WARRANTY SERVICE:** You must take your motor scooter, along with your warranty registration card or other proof of purchase date, at your expense, to any dealer within the United States, Puerto Rico, or the U.S. Virgin Islands who is authorized by American Honda to sell motor scooters, during his normal business hours. If you are unable to obtain, or are dissatisfied with, the warranty service you receive, take the following steps: first, contact the owner of the dealership involved; normally this should resolve your problem. However, if you require further assistance, write or call the Customer Relations Department at the regional office of American Honda Motor Co., Inc. in your area. Regional office locations are shown on the other side of this page.

**EXCLUSIONS:** THIS WARRANTY DOES NOT EXTEND TO PARTS AFFECTED OR DAMAGED BY ACCIDENT AND/OR COLLISION, MISUSE, NEGLIGENCE, NORMAL WEAR, THE INCORPORATION OF, OR USE OF UNSUITABLE ATTACHMENTS OR PARTS, OR THE UNAUTHORIZED ALTERATION OF ANY PART. USE OF THE HONDA MOTOR SCOOTER FOR RACING, COMPETITION OR RENTALS WILL VOID THIS WARRANTY.

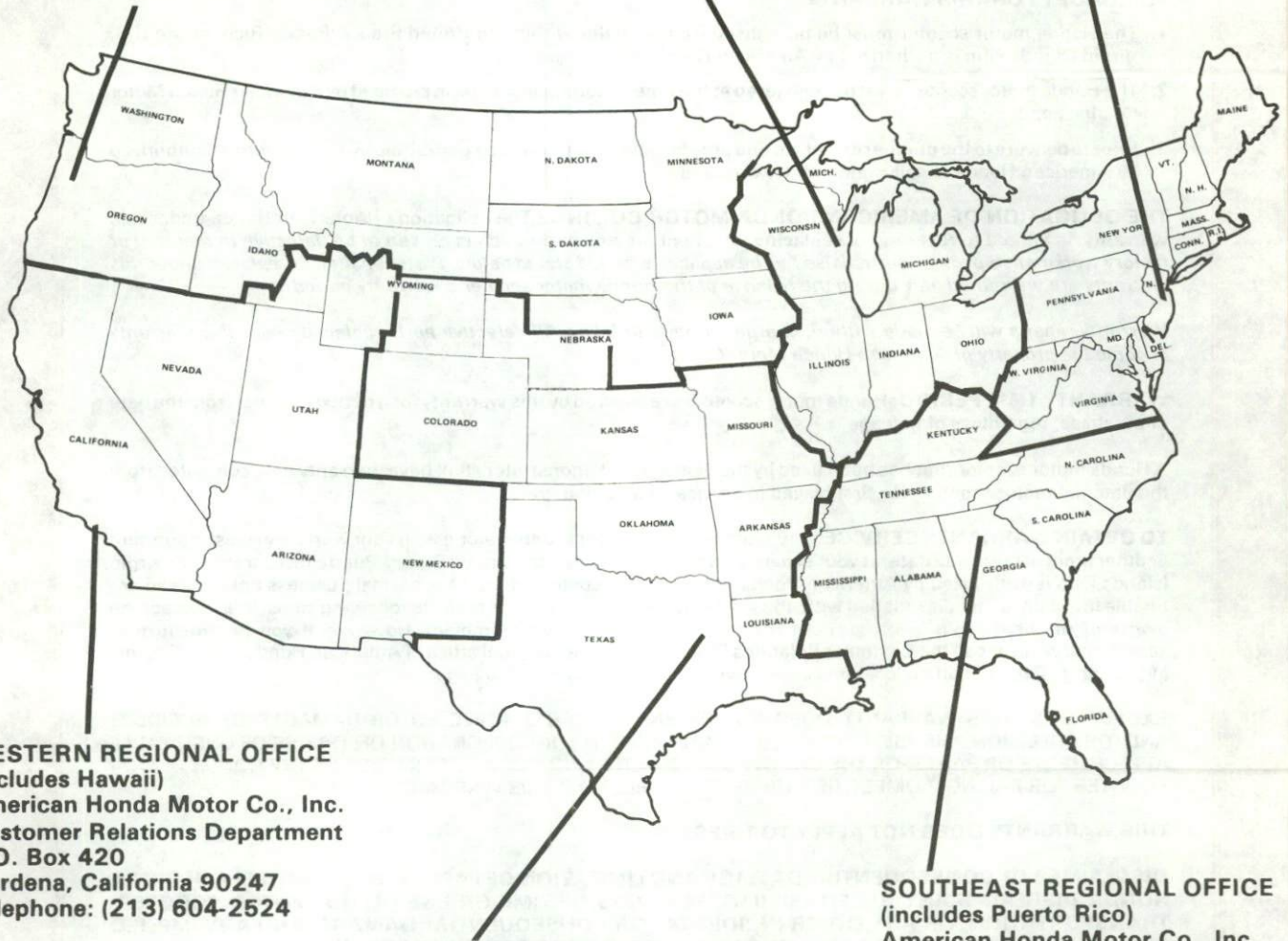

# Distributor's Warranty

## HONDA MOTOR SCOOTER EMISSION CONTROL SYSTEM

This warranty applies only to Honda motor scooters distributed by American Honda Motor Co., Inc., 100 West Alondra Boulevard, Gardena, California 90247, and sold by American Honda or dealers within the United States, Puerto Rico, and the U.S. Virgin Islands authorized by American Honda to sell motor scooters.

**TO QUALIFY FOR THIS WARRANTY:** The Honda motor scooter must be purchased in the United States, Puerto Rico, or the U.S. Virgin Islands.

**THE OBLIGATION OF AMERICAN HONDA MOTOR CO., INC.:** American Honda warrants to the first retail purchaser and each subsequent purchaser that the motor scooter warranted hereunder is designed, built and equipped so as to conform at the time of sale with all U.S. emission standards applicable at the time of manufacture and that it is free from defects in material and workmanship which would cause it not to meet applicable emission regulations within the time and mileage period stated below.

Warranty repairs will be made without charge for parts or labor. All defective parts replaced under this warranty become the property of American Honda Motor Co., Inc.

**THE OBLIGATION OF THE HONDA MOTOR SCOOTER OWNER:** The owner of the Honda motor scooter is to have required maintenance performed in accordance with the maintenance schedule contained in the owner's manual. Failure to have required maintenance performed may result in losing coverage under this warranty. Claims for repairs or adjustments found to be caused solely by defects in materials or workmanship will not be denied because the motor scooter or engine was not properly maintained and used.

**TIME AND MILEAGE PERIOD:** Honda motor scooters with engine displacement of 50 to 169 cubic centimeters are covered by this warranty for a period of 5 years or 12,000 kilometers (7,456 miles), whichever occurs first.

The warranty time and mileage period shall begin on the date the motor scooter is delivered to the first retail purchaser, or on the date the motor scooter is first placed in service as a demonstrator, rental, lease, or company motor scooter prior to retail sale.

**TO OBTAIN WARRANTY SERVICE:** You must take your Honda motor scooter, along with your warranty registration card or other proof of original purchase date, at your expense, to any dealer within the United States, Puerto Rico, or the U.S. Virgin Islands who is authorized by American Honda to sell motor scooters, during his normal business hours. You may also be required to show that you have performed required maintenance which is related to the alleged defect, so you should also have your Honda Motor Scooter Owner's Manual Maintenance Record, or other detailed receipts demonstrating that applicable required maintenance has been performed in accordance with the maintenance schedule contained in your manual. If you are unable to obtain, or are dissatisfied with the warranty service you receive, take the following steps: first, contact the owner of the dealership involved; normally this should resolve your problem. However, if you require further assistance, write or call the Customer Relations Department at the regional office of American Honda Motor Co., Inc. in your area. Regional office locations are shown on the other side of this page.

**EXCLUSIONS:** FAILURES OTHER THAN THOSE RESULTING FROM DEFECTS IN MATERIAL OR WORKMANSHIP ARE NOT COVERED BY THIS WARRANTY. THIS WARRANTY DOES NOT EXTEND TO EMISSION CONTROL SYSTEMS OR PARTS WHICH ARE AFFECTED OR DAMAGED BY LACK OF REQUIRED MAINTENANCE, OWNER ABUSE, MISUSE, ACCIDENT AND/OR COLLISION, THE INCORPORATION OF, OR USE OF, UNSUITABLE ATTACHMENTS OR PARTS, OR THE UNAUTHORIZED ALTERATION OF ANY PART.

THIS WARRANTY DOES NOT COVER REPLACEMENT OF EXPENDABLE MAINTENANCE ITEMS MADE IN CONNECTION WITH REQUIRED MAINTENANCE SERVICES, SUCH AS: SPARK PLUGS, IGNITION CONTACT POINTS AND CONDENSERS, FILTERS, AND LUBRICANTS.

USE OF THE HONDA MOTOR SCOOTER FOR RACING OR COMPETITION, OR ALTERATION OF THE ODOMETER MILEAGE, MAY VOID THIS WARRANTY.

THIS WARRANTY DOES NOT APPLY TO ANY HONDA MOTOR SCOOTER WITH AN ACTUAL ENGINE DISPLACEMENT OF LESS THAN 50 CUBIC CENTIMETERS.

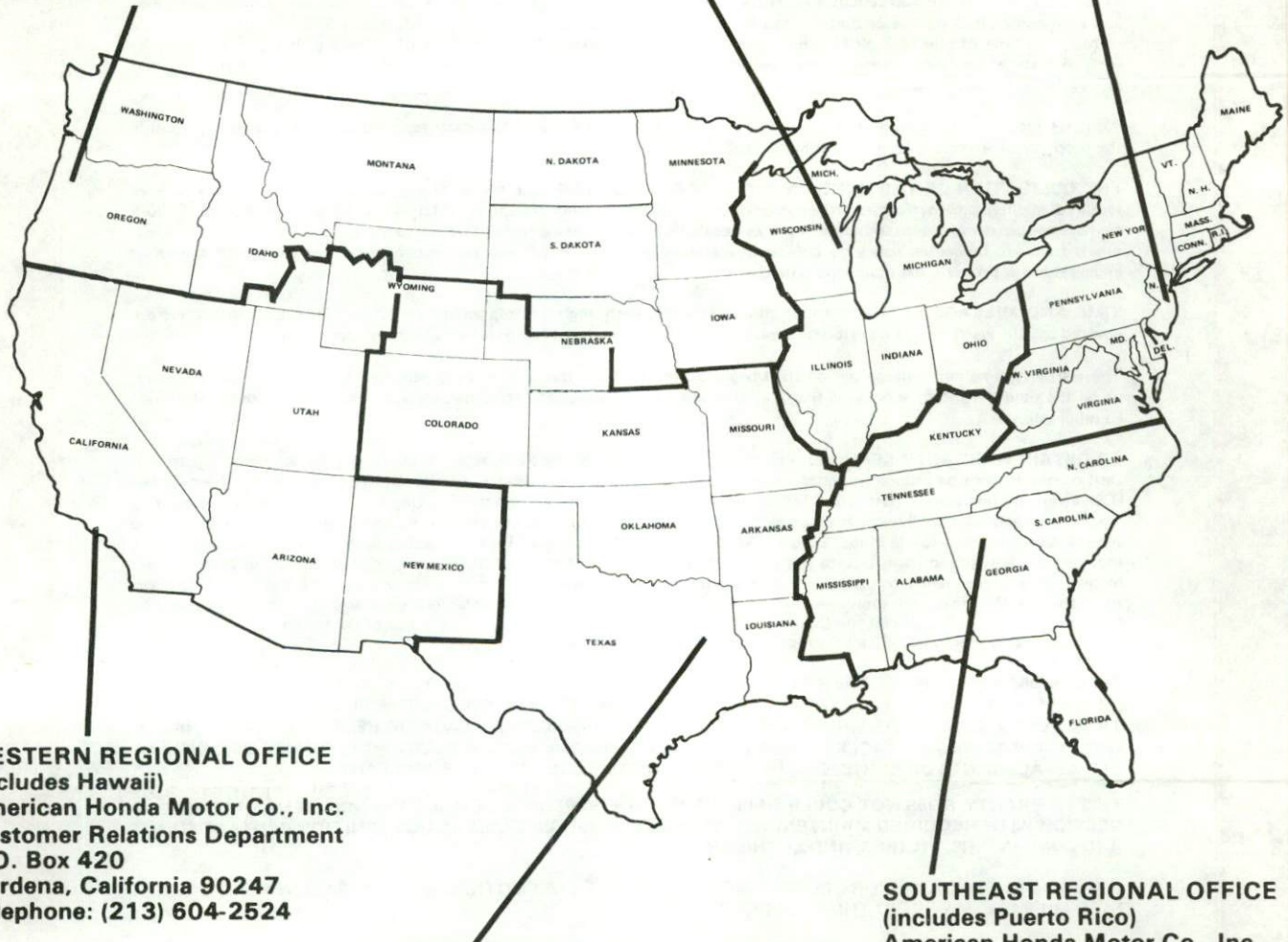

## **MOTOR SCOOTER EXHAUST SYSTEM INFORMATION SHEET**

### **NOISE EMISSION WARRANTY**

AMERICAN HONDA MOTOR CO., INC. warrants that this exhaust system, at the time of sale, meets all applicable U.S. E.P.A. Federal noise standards. This warranty extends to the first person who buys this exhaust system for purposes other than resale, and to all subsequent buyers. Warranty claims should be directed to the American Honda Motor Co., Inc., 100 West Alondra Boulevard, Gardena, California 90247 (213) 321-8680.

### **TAMPERING PROHIBITION**

Federal law prohibits any modification to this exhaust system which causes the motor scooter to exceed the Federal noise standard. Use of the motor scooter with such a modified exhaust system is also prohibited. Acts likely to constitute tampering include removal or puncturing the muffler, baffles, header pipes, or any other component which conducts exhaust gases.

### **WARNING STATEMENT**

**WARNING:** This product should be checked for repair or replacement if the motor scooter noise has increased significantly through use. Otherwise, the owner may become subject to penalties under state and local ordinances.

## HONDA MOTOR SCOOTER NOISE CONTROL SYSTEMS

This warranty applies only to new Honda motor scooters manufactured on or after January 1, 1983, distributed by American Honda Motor Co., Inc., 100 West Alondra Boulevard, Gardena, California 90247, and sold by American Honda or its authorized Honda dealers within the United States, Puerto Rico, and the U.S. Virgin Islands.

This warranty is in addition to the Distributor's Limited Warranty and is the only express noise control systems warranty applicable to Honda motor scooters.

**TO QUALIFY FOR THIS WARRANTY:** The Honda motor scooter must be purchased in the United States, Puerto Rico, or the U.S. Virgin Islands.

**THE OBLIGATION OF AMERICAN HONDA MOTOR CO., INC.:** American Honda warrants to the first retail purchaser and each subsequent purchaser that the motor scooter warranted hereunder is designed, built and equipped so as to conform at the time of first retail purchase with all applicable U.S. EPA noise emission standards, and that when properly maintained and used, it will meet applicable noise emission regulations within the time and mileage periods stated below.

The obligation of American Honda under this warranty is limited to repairing or replacing, at its option, any part of the exhaust systems, or exhaust systems components, which are *proven to be defective in material or factory workmanship under normal use* for the warranty period stated below. Parts repaired or replaced under this warranty are only warranted during the balance of the Honda motor scooter Noise Control Systems' warranty period.

Warranty repairs will be made without charge for parts or labor. All defective parts replaced under this warranty become the property of American Honda Motor Co., Inc.

**THE OBLIGATION OF THE HONDA MOTOR SCOOTER OWNER:** The owner of the Honda motor scooter is to have required maintenance performed in accordance with the maintenance schedule contained in the owner's manual. Failure to have required maintenance performed may result in losing coverage under this warranty. Claims for repairs or adjustments found to be caused solely by defects in materials or workmanship will not be denied because the motor scooter or engine was not properly maintained and use.

**TIME AND MILEAGE PERIOD:** Honda motor scooters are covered by this warranty for a period of 12 months from the date of first retail purchase, or 3730 miles, whichever occurs first.

**TO OBTAIN WARRANTY SERVICE:** You must take your Honda motor scooter, at your expense, to any authorized Honda motor scooter dealer in the United States, Puerto Rico, or the U.S. Virgin Islands during normal business hours, and you must take with you your warranty registration card or other proof of original purchase date. You may also be required to show that you have performed required maintenance which is related to the alleged defect, so you should also have your Honda Motor Scooter Owner's Manual Maintenance Record, or other detailed receipts demonstrating that applicable required maintenance has been performed in accordance with the maintenance schedule contained in your owner's manual. If you are unable to obtain or are dissatisfied with the warranty service you receive, take the following steps: first, contact the owner of the dealership involved; normally this should resolve your problem. However, if you require further assistance, write or call the Customer Relations Department at the regional office of American Honda Motor Co., Inc. in your area. Regional office locations are shown on the other side of this page.

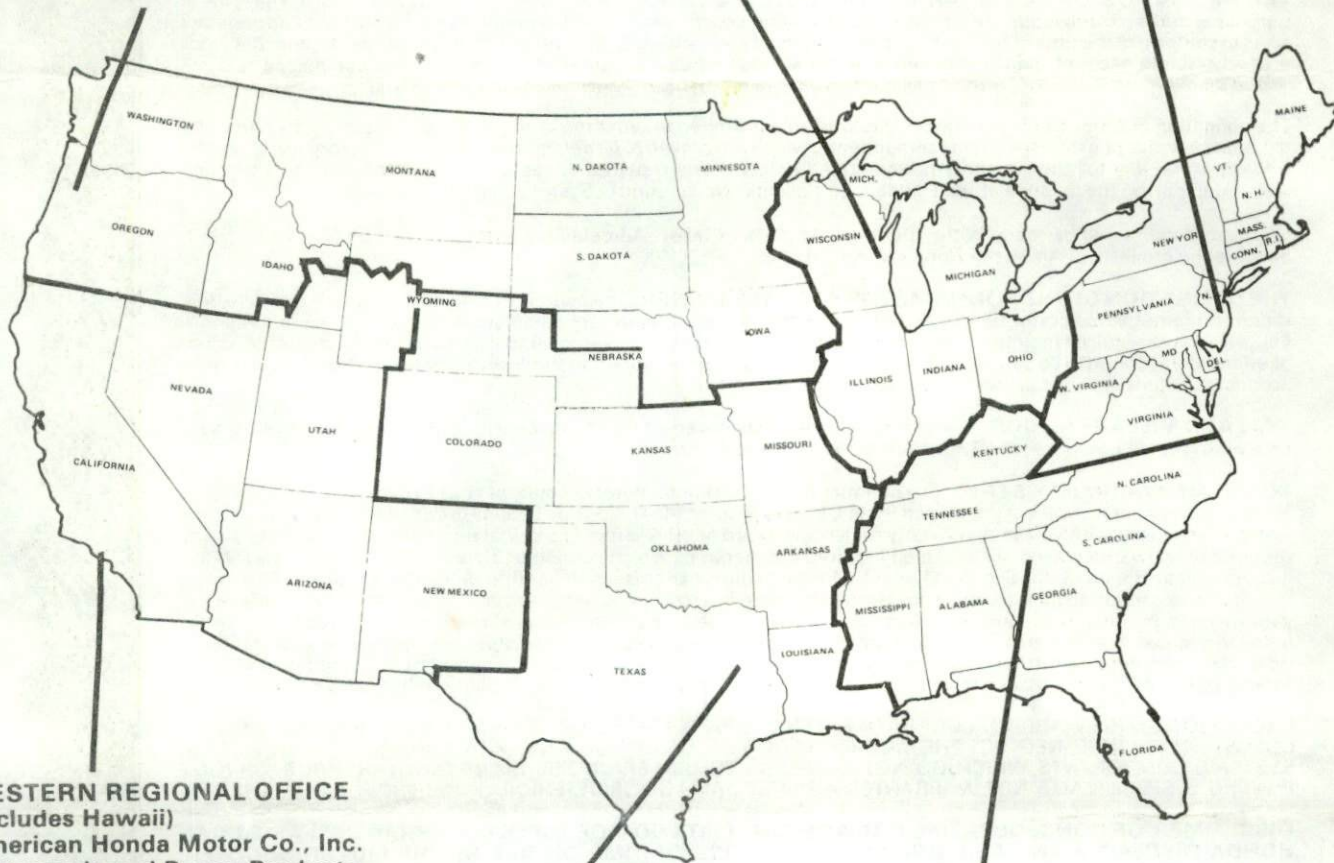
